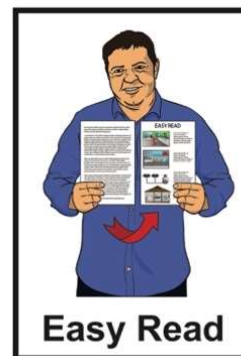

# What this Easy Read is about

## Disability Support Services

This information is for people who get supports from Disability Support Services.



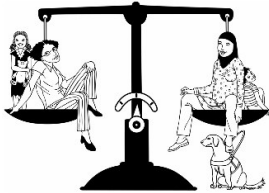
The information in this factsheet is true as of February 2026.

In September 2025 the Government said there would be changes to disability support services.

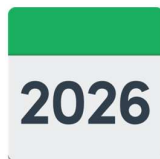


The changes are about:

- making things fair for everyone
- giving disabled people more choice and control over their **flexible funding**.



Here **flexible funding** is money from Disability Support Services that you can choose how to spend.



These changes will start from the middle of February 2026.

# What is happening in February



The February changes are about making a better way to:

- find out what disabled people need
- decide what funding is offered for supports.



From the middle of February 2026 these things will be done in the same way by all:



- **Needs Assessment Service Coordination organisations**
- **Enabling Good Lives sites.**

Enabling Good Lives



Disabled people can be supported by:

- **Needs Assessment Service Coordination organisations**
- **Enabling Good lives sites.**



Both support disabled people to work out:

- what they need for a good life
- what support they can get.

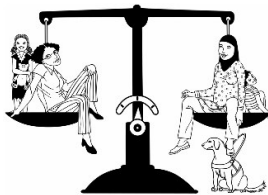


In this Easy Read **Needs Assessment Service Coordination organisations** are called **NASCs**.



Here an **assessment** means working with a NASC / Enabling Good Lives site to decide the support you:

- need
- will get.



Doing assessments the same way will make things:

- fairer for everyone
- the same no matter where you live in New Zealand.



This change will be for people who:

- are applying for DSS support for the first time
- have a **reassessment** in the future.





Here a **reassessment** is when a NASC / Enabling Good Lives site checks you are getting the right support for your needs.



## What will be different

Before the assessment you will be given information about what you can expect to happen.



If support from other people is important to your needs then:

- the needs of your whānau / family may also be part of the assessment
- the needs of your carers may also be part of the assessment.



Whānau / family can also be carers.





After your assessment you will have a clear plan about:

- your needs
- your disability supports.



These changes have been made because we heard from the disability community that the way assessments were done was:

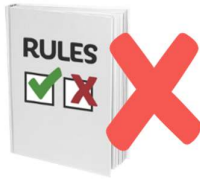
- confusing
- not the same everywhere.



## What is happening in April



You will get more choice and control over how you use your flexible funding on disability supports.



The **purchasing guidelines** will be taken away.



The **purchasing guidelines** are the rules about how people can spend their disability support funding.

# Budgets



You will be given a **budget** if you get flexible funding.



A **budget** tells you how much money you can spend.



You cannot spend more than your budget says.

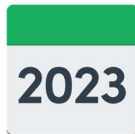


There will be support to manage your budget if you need it.



We will decide what your budget will be by looking at:

- if your needs have changed
- if your funding has changed
- what you spent between:



- June 2023

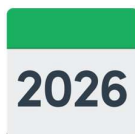
and



- June 2025.



No one will get less money than what they have spent before.



We will let people know about their budget for flexible funding before April 2026.

## What happens now?

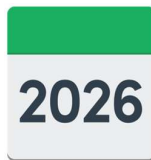


You do not need to do anything now.



You will still be supported by your:

- NASC
- Enabling Good Lives site
- Host.



The purchasing guidelines will still be the rules we follow until April 2026.



This will be true even if you have just had an assessment.
